## **Terms and Conditions (See Park Vendor Guidelines)**

- 1. All products will be approved by Everett Parks & Facilities prior to space assignment.
- 2. Vendor will keep products contained in the rented space.
- 3. Vendor is responsible for cleaning up the area.
- 4. All products must be removed from the park by closing time.
- 5. The City of Everett is not responsible for any damage and/or loss of any product at any time.
- 6. All vendors must pay all necessary business licenses and permit fees and all applicable taxes.
- 7. Everett Parks & Facilities will be in charge of assigning all spaces. The space assignment will be on a first-come-first-serve basis.
- 8. For vendors requesting electricity, a request must be received 3 business days prior to requested date of vending (Wetmore Theatre Plaza only).
- All vendors serving food or drinks must provide a copy of their certificate of insurance evidencing Commercial General liability insurance with limits no less than \$1,000,000 combined single limit per occurrence noting City of Everett, its officers, agents and employees, 2930 Wetmore Ave, Everett WA 98201 as additional insured.
- 10. All vendors serving food or drinks must provide a copy of their food handler's permit and proof of contract with the Snohomish County Health Department (their phone number is 425-339-5250).
- 11. Applicant must be the same person as the vendor.
- 12. A City of Everett business license is required.
